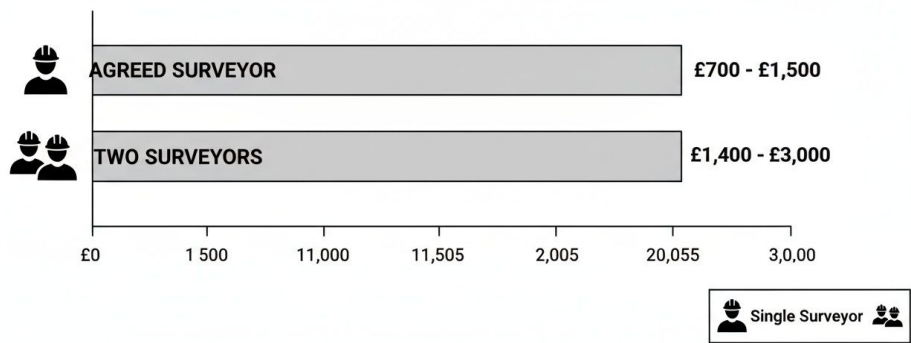


# PARTY WALL SURVEYOR COSTS
