

Brookline has always felt like a town with one foot in Boston and the other planted firmly in its own history. It is close enough to the city to absorb its energy, yet distinct enough to keep a personality shaped by village greens, brick schoolhouses, old estates, and long residential blocks that still carry the memory of earlier centuries.
