

What the Anion Gap Evaluates

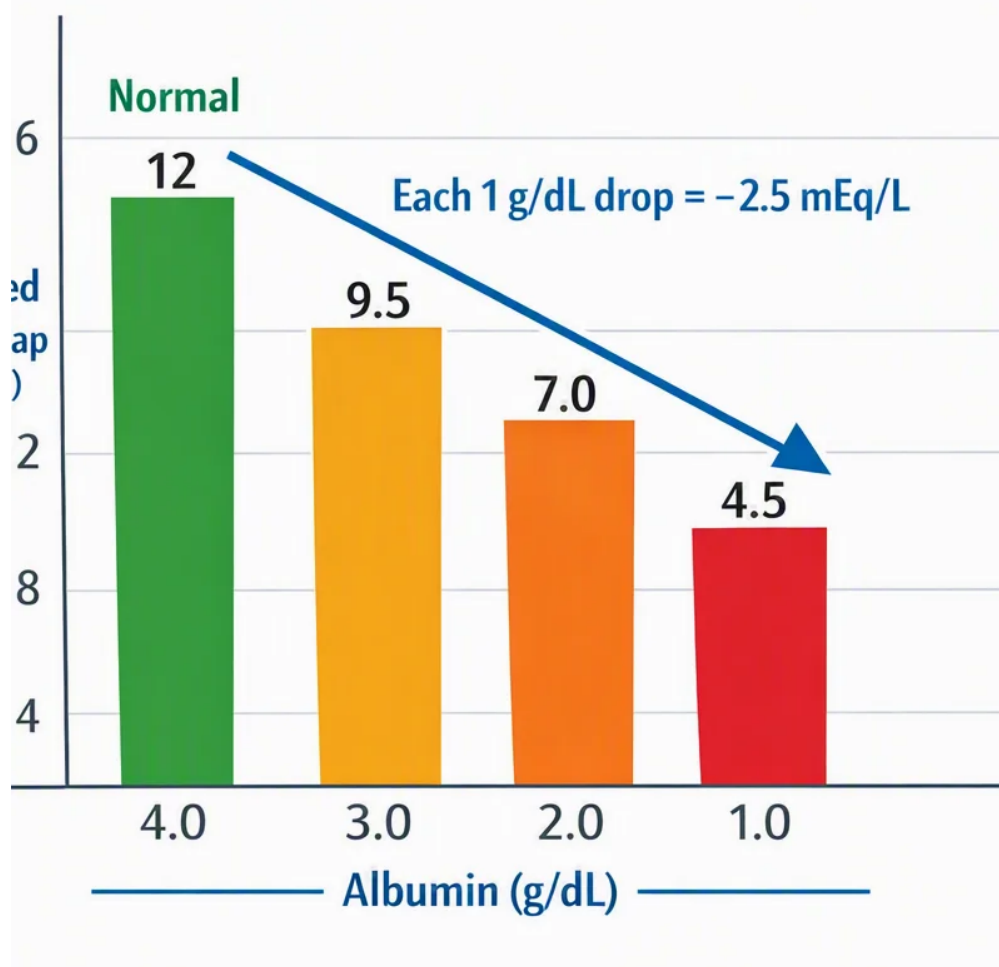
