

What Is the Anion Gap?

The **anion gap** is a derived value used in acid-base balance to help detect hidden acids in the blood. It is derived from the **serum electrolytes**, especially **sodium, chloride**, and bicarbonate, and it serves as a helpful laboratory interpretation tool during a biochemical evaluation.

In its standard form, the anion gap reflects the difference between measured cations and measured anions. Because some charged particles are not directly reported on a standard electrolyte panel, the gap helps clinicians recognize the presence of *unmeasured anions*. 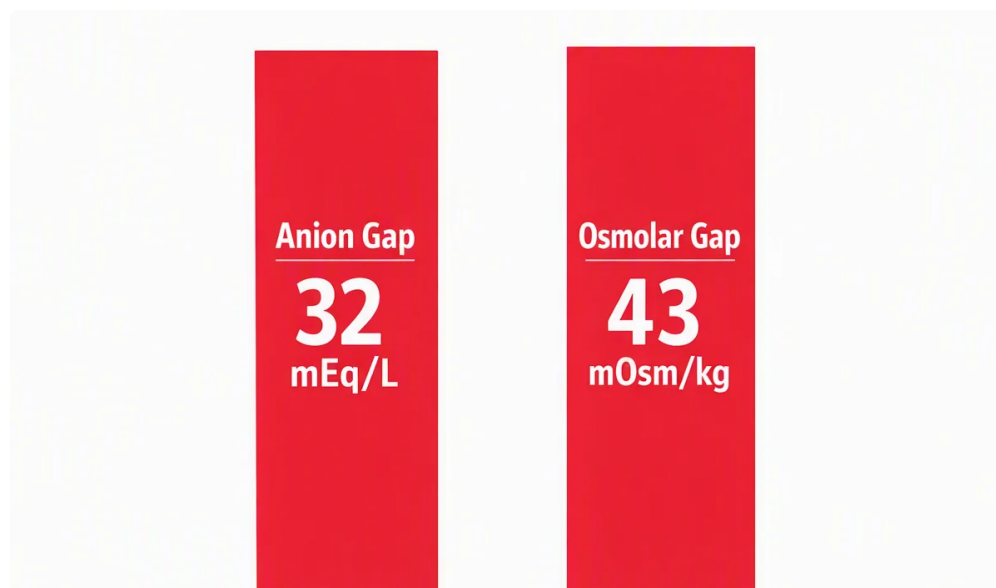
