

If you ride and a driver did not see you around Atlanta, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.

These cases get built on **affordable personal injury lawyer** physical evidence rather than narrative, because narrative starts at a disadvantage. The geometry of the turn carry more weight than either version of events.

Severity helps and hurts. There is nothing around a rider, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
