If the app is off, it is an ordinary car wreck, and their personal policy applies. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each position can reach a different layer of coverage.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. How long do I have to file an injury claim in Georgia?

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. What should I do after a truck accident in Atlanta?

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
