

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and only [truck wreck attorney Atlanta](#) the personal policy is in play. When the app is on and they are waiting for a ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
