

If you were hurt by electrical contact around Atlanta, the answer is rarely a single company.

A site has an owner, the general contractor, the electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not bar [truck injury lawyer](#) a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
