

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each one can reach different policies.
