

# What's an Anion Gap Calculator?

An **anion gap calculator** is a diagnostic tool used to determine the **anion gap** from typical **serum electrolytes**. The calculation commonly uses **sodium**, **chloride**, and **bicarbonate** from a **serum chemistry panel** to help assess **acid-base balance**. Because the anion gap represents the difference between measured cations and measured anions, it can indicate the presence of **unmeasured anions** that are not obvious on standard laboratory testing.

The correction factor of 2.5 indicates the approximate rise in anion gap for each 1 g/dL decrease in serum albumin below the reference interval.

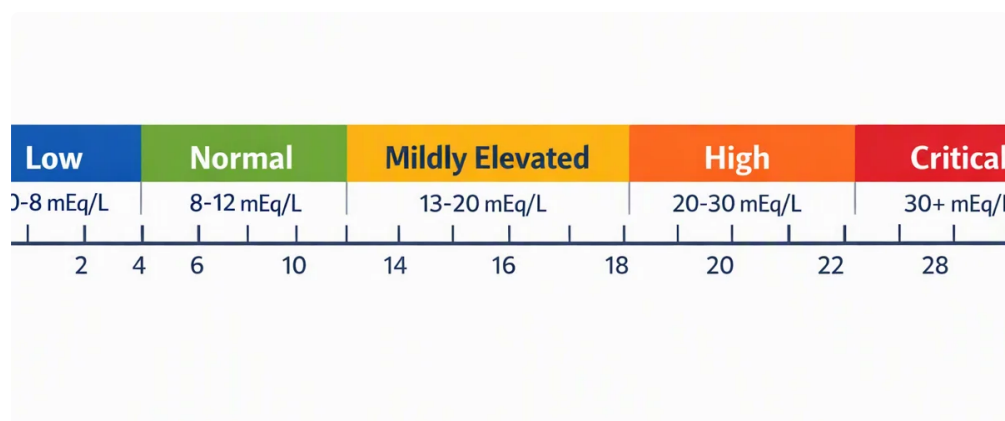
Suppose the patient has:

- Sodium = 140 mEq/L
- Chloride = 104 mEq/L
- Bicarbonate = 20 mEq/L
- Albumin = 2.0 g/dL

First, calculate the **measured anion gap**:

$$140 - (104 + 20) = 16$$

Now apply the **albumin correction**:



$$\text{Corrected anion gap} = 16 + 2.5 \times (4.0 - 2.0)$$

$$\text{Corrected anion gap} = 16 + 2.5 \times 2$$

$$\text{Corrected anion gap} = 16 + 5$$

$$\text{Corrected anion gap} = 21$$

The corrected value is 21, which is over the expected **normal range** in many settings and may support concern for **elevated anion gap metabolic acidosis**. Without correction, the patient's gap of 16 might have seemed only mildly elevated or even borderline, depending on the **lab reference range**.
