

If you were hurt in a fall in Atlanta, the claim is not as simple as it looks. Proving the hazard existed is only the start.

Under Georgia law you generally have to show that the owner had notice of the condition, caused it themselves, or should have found it through reasonable inspection.

This is the reason the opening weeks decide these cases. Camera footage does not last long, and without it you cannot establish how long the condition existed.

The report the store writes come from the business itself, which affects what ends up in them. The store's own **Find more info** inspection records are just as important, since a written policy that was ignored says a great deal.
