

When a rider is hurt and were hit in Georgia, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. The geometry of the turn carry more weight than either version of events.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
