

If you or your child were bitten in the Atlanta area, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia [big rig accident lawyer](#) is not one of them. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. County records and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
