

What the Anion Gap Shows in Blood Chemistry

The **anion gap** is a computed value used in laboratory chemistry to aid in interpreting **electrolytes** and understand **acid-base balance**. It represents the difference between major measured cations and anions in the blood, mainly **sodium** and **chloride**, with bicarbonate included in the comparison. 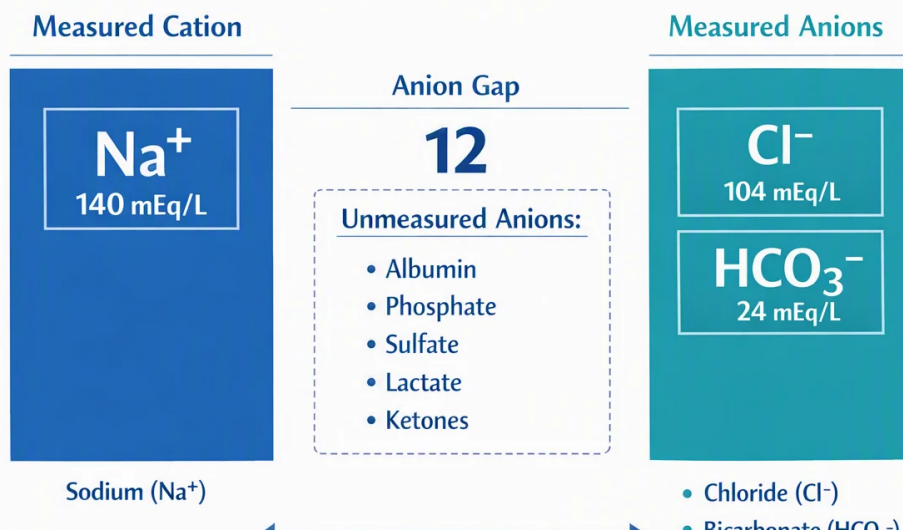
