

If you ride and were hit in Atlanta, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, https://wiki-fusion.win/index.php/Atlanta_Personal_Injury_Lawyer because narrative starts at a disadvantage. Scene measurements do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
