

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer turns on what the app was doing when the crash happened.

If the app is off, it is [Article source](#) an ordinary car wreck, and their personal policy applies. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the records that prove it sit with the rideshare company, not with you.

Whether you were riding, driving another car, walking or on a [truck accident lawyer](#) bike changes the analysis too. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
