

If you ride and were hit in Atlanta, the assumption is already working against you.

People arrive with a view already formed: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes it [big rig accident lawyer](#) fits. More often a driver looked and did not register a single headlight.

Reconstruction matters more here than testimony, since the story is doubted before it is told. Damage patterns carry more weight than either version of events.
