

If [truck accident lawyer](#) you or your child were bitten in Atlanta, Georgia works differently than people expect.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether anyone contacted animal control.

This evidence does not last. Prior complaints and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
