

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.

That timing is not a small detail. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
