

Losing someone in a preventable crash is not a legal problem first. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people [atlanta personal injury attorney](#) expect. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines [Atlanta injury claims lawyer](#) apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, especially when a company vehicle or a business is involved.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
