

Losing someone in a preventable crash is not a legal problem first. It becomes one later, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers the last [local 18-wheeler accident lawyer](#) medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
