

Losing someone in a preventable crash is not a legal problem first. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. Where [Check out here](#) there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, especially when a company vehicle or a business is involved.
