

If a dog bit you in Georgia, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Establishing what the owner <https://telegra.ph/Metro-Atlanta-Tractor-Trailer-Wrecks-Why-the-First-Days-Matter-09-01> knew is not easy. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

These records fade fast. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
