

What Is the Anion Gap?

The **anion gap** is a derived measure used to assess **acid-base balance** and recognize certain kinds of **electrolyte imbalance**. It comes from a routine **serum chemistry** panel and weighs measured positive ions with measured negatively charged ions in the blood. In practical terms, it allows clinicians detect a hidden **metabolic derangement** that may not be obvious from symptoms alone.

How to Calculate the Anion Gap Step by Step

Calculating the anion gap is easy when you have the main electrolyte values. The standard steps use **sodium**, **chloride**, and **bicarbonate**, with optional inclusion of **potassium**.

- First step: Get the serum electrolyte values from the lab report.
- Next step: Confirm the values for **serum sodium**, **serum chloride**, and **serum bicarbonate**.
- Then: Add chloride and bicarbonate together.
- Last: Take away that sum from sodium.

Using the basic formula:

Anion gap = sodium - (chloride + bicarbonate)

If the calculator uses potassium, include it to the sodium value before subtracting **Check out this site** the other electrolytes. Potassium is generally a lesser component of the formula, but it can somewhat change the result.

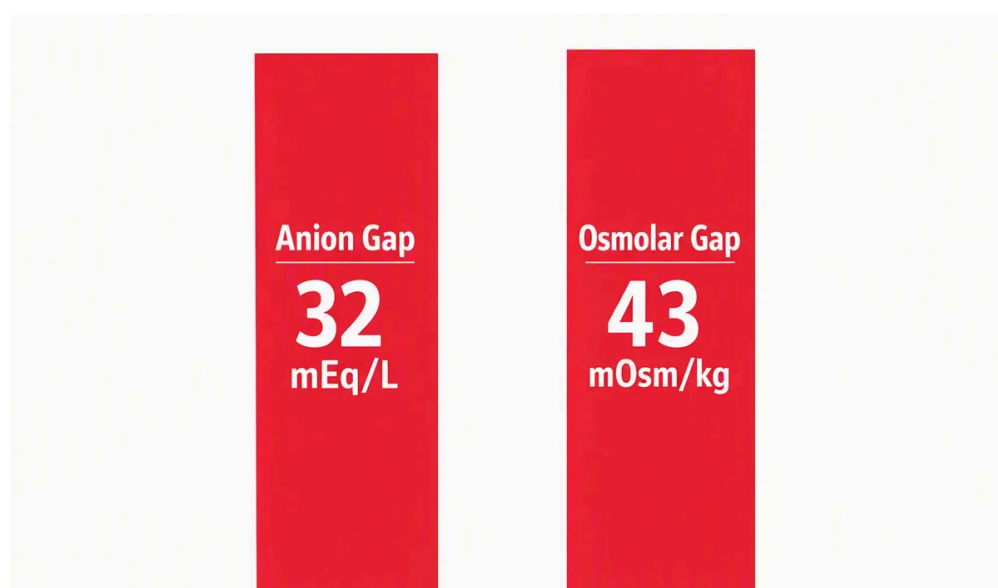
Revised Anion Gap and Albumin Correction
