

If you ride and a driver did not see you in Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: that the rider was speeding, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Damage patterns carry more weight than either version of events.

Severity [personal injury law firm](#) helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
