

Getting hit by an 18-wheeler is not a bigger fender bender. A loaded tractor trailer can weigh many times what your car weighs, and people tend to get hurt much worse.

The difference shows up immediately. Trucking companies frequently send an investigator to the scene the same day, before you are out of the hospital. They begin building the company's side of the case right away.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
