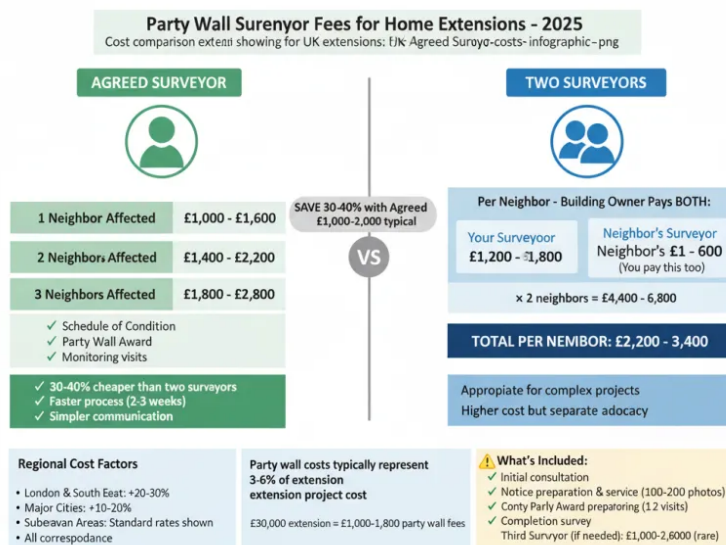

Below is a list of some of the jobs that will require you to have an Event Wall Agreement in place. An Event Wall Honor is valid for a duration of one year from the date of its service.
