- When it concerns home improvements and expansions, preserving good relationships with your neighbors can sometimes be as crucial as the building work itself.

Forward the Party Wall Notice to your appointed surveyor. You must select a surveyor whose fees will be met by the building owner.

Return your response form to the building owner. This indicates you are consenting to the notice.

Both you and your neighbour's surveyor will conduct a survey of all parts of your property that is relevant before work begins. Also a Party Wall Award, a legal documentation is produced.

Your neighbour can now commence work. But they surveyors will return on completion to inspect for ANY damage made to your property.
