

If you ride and someone turned across your path around Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle [personal injury attorney](#) and turned across it.

The work is physical evidence, not story, since the story is doubted before it is told. Sight line analysis do the arguing.
