

If you were riding and a driver did not see you in Atlanta, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was going <https://www.instapaper.com/read/2033635731> too fast, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.

The work is physical evidence, not story, since the story is doubted before it is told. Scene measurements do the arguing.

Injury severity cuts both ways. There is nothing around a rider, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
